

## **Addicted2Salsa Contest Rules, Terms & Conditions**

1. **ELIGIBILITY:** SO YOU THINK YOU CAN DANCE season premiere contest/giveaway is open only to U.S. residents who are at least eighteen (18) years old at the time of entry. All employees, agents, and contractors of Addicted2Salsa are not eligible. All applicable federal, state and local laws and regulations apply. Void where prohibited or restricted.

2. **CONTEST PERIOD:** The Contest begins at 12:00 p.m. Pacific Time on May 5, 2008 and ends at 11:59 p.m. PT on May 25, 2008. The Contest Period consists of a video submission phase, which begins May 5, 2008 and ends May 19, 2008, and a voting period, which begins May 19, 2008 and ends May 25, 2008.

3. **CONTEST SUBMISSION:**

a. **Video Submission Phase:** During the Promotion visit <http://www.youtube.com> and login or create a YouTube Account. Creating an account is free. Follow the links and instructions to submit a video featuring your original dance combination. Participant must be a contributing member of the dance combination in the Submission.

**Submission Requirements:**

- \* Participants must have a YouTube account and a valid iTunes account.
- \* Submission must contain an original salsa dance combination or footwork pattern.
- \* Participant must own all copyright and performance rights to music and video submission.
- \* Submission must not exceed 45 seconds in length.

During the registration process, each participant will be required to click where indicated to confirm that such participant agrees to be bound by these Official Rules. Any Submission that includes content that is deemed inappropriate, indecent, and obscene or otherwise does not comply with the YouTube Terms of Service located at <http://youtube.com/t/terms>, as determined by Sponsor in its sole discretion, will not be eligible. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, or misdirected entries, which are void. In addition, by entering, contestants represent and warrant that the entries that they submit: are their own original creations, do not infringe any other person's or entity's rights and has obtained permission from the people featured in the Submission to enter this Contest.

**Voting Period:** Sponsor will post Submissions that comply with Official Rules. During the Voting Period, visitors to the website will be invited to vote for their favorite Submission. **Finalists:** The Participants whose Submissions are chosen as the top ten (10) videos by Addicted2Salsa staff will be the potential finalists for the Grand

Prize consideration. The top three (3) videos will be decided by an online vote, open to all Addicted2Salsa visitors. Limit: Visitors to the site may vote one (1) time for each Submission during the Voting Period. Voters must be at least thirteen (13) years of age. In the case of a tie, the qualified judges will determine the winner.

4. JUDGING/REQUIREMENTS OF CONTEST WINNERS: Videos will be judged based on style, technique, and above all, creativity. The winning video will be the BEST dance combination, based on these qualities.

This will be provided by Big Honcho Media in conjunction with FOX. **SECOND PLACE:** \$20 iTunes gift card, provided by Addicted2Salsa. **THIRD PLACE:** \$10 iTunes gift card, provided by Addicted2Salsa. In order to receive second and third place prizes the recipients must have a valid iTunes account. No cash equivalent will be made available on prizes. Prizes are non-transferable.
